## **Information Collection And Use**

We collect several different types of information for various purposes to provide and improve our Service to you.

### **Types of Data Collected**

#### **Personal Data**

While using our Service and/or engaging M&B Medical Marketing Sdn. Bhd. for any services, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data").
